**Order made by the Electoral Supervisory Commission under section 39 of  
the Representation of the People Act**

1. This Order may be cited as the Representation of the People (Variation of Dates) Order, 2021.
2. The dates set out in the third column of the Schedule to this Order, being dates specified in the sections of the Representation of the People Act, indicated in the first column of the Schedule, shall, in respect of the compilation of the register of electors for every electoral area, be varied in the year 2021, in the manner set out in the fourth column of the Schedule.
