MUNICIPAL CITY COUNCIL AND MUNICIPAL TOWN COUNCIL ELECTIONS, 2015

SUBMISSION OF LISTS OF RESERVE CANDIDATES

Any registered group contesting the forthcoming election of Councillors to a Municipal City Council or Municipal Town Council may submit to the Electoral Supervisory Commission on **Thursday 28 May, 2015** a list of **not more than six (6) reserve candidates** for that Municipal City Council or Municipal Town Council election, for the purpose of filling, under Section 42 of the Local Government Act, any vacancy which may occur after that election.

The reserve list shall be in compliance with Section 18(5) of the Local Government Act and shall specify the name, sex, National Identity Card number, address, occupation and the elector's number of each candidate (where applicable) **in order of precedence** and shall be signed by each candidate.

The list shall also be signed by the president **and** secretary of the group who shall declare that -

- (a) the reserve list does not comprise more than two-thirds of persons of the same sex; and
- (b) not more than two consecutive candidates on the said reserve list are of the same sex.

The president and secretary of the group shall also certify that, to the best of their knowledge and belief, none of the candidates included on the said list –

- (a) is a person whose name is included on any other reserve list submitted by a group for the election of Municipal City Councillors, Municipal Town Councillors or Village Councillors;

- (b) is a candidate for the election of Municipal City Councillors or Municipal Town Councillors; and
- (c) is a Village Councillor.

The list shall be accompanied by a **declaration made by each candidate** that –

- (a) he is qualified to be elected a Councillor of the said Municipal City Council/ Municipal Town Council;
- (b) he is not disqualified from being elected a Councillor of the said Municipal City Council/Municipal Town Council;
- (c) he is a member of the said group;
- (d) he has not been, nor will he consent that his name be, included on any other reserve list submitted by a group for the Municipal City Council and Municipal Town Council elections;
- (e) he is not a candidate for the Municipal City Council and Municipal Town Council elections; and
- (f) he is not a Village Councillor.

In the case of an alliance –

- (i) each group forming part of the alliance may submit a reserve list;**
- (ii) no reserve list shall be submitted by the alliance itself.**

The prescribed forms of “List of Reserve Candidates” (Form 7) and “Declaration of Candidate on Reserve List” (Form 8) may be obtained at the Office of the Electoral Commissioner or downloaded from the website of the said Office at <http://electoral.govmu.org>

The completed forms shall be received by the Electoral Supervisory Commission at the Office of the Electoral Commissioner, MaxCity Building, Corner Remy Ollier and Louis Pasteur Streets, Port Louis on **Thursday 28 May, 2015** between the hours of **9.30 a.m. and 12.00 noon** and between **12.30 p.m. and 3.30 p.m.**
