### THE REPRESENTATION OF THE PEOPLE ACT

### Regulations made by the President under section 85 of the Representation of the People Act

**1.** These regulations may be cited as the National Assembly Elections (Amendment No. 2) Regulations 2024.

2. In these regulations –

"principal regulations" means the National Assembly Elections Regulations 2014.

**3.** Regulation 2 of the principal regulations is amended by inserting, in the appropriate alphabetical order, the following new definition –

"Form 6B" means the form set out in Part III of the Sixth Schedule;

4. Regulation 18 of the principal regulations is amended, in paragraph (1)(a), by deleting the words "one polling agent" wherever they appear and replacing them by the words "not more than 2 polling agents".

5. Regulation 21 of the principal regulations is amended, in paragraph (2), in subparagraph (b)(i), by deleting the words "Form 6A" and replacing them by the words "Form 6A or Form 6B".

**6.** The Sixth Schedule to the principal regulations is amended by adding the new Part III set out in the Schedule to these regulations.

#### DIRECTIONS AS TO PRINTING OF BALLOT PAPER

The directions contained in Form 6 shall be followed for the printing of Form 6B, subject to the following further arrangements –

(a) on both the recto and the verso of the ballot paper, a thick vertical line shall separate the ballot paper into 2 equal spaces, the candidates being listed in alphabetical order, starting on the recto of the ballot paper in the left-hand column, then continuing in the right-hand column, thereafter continuing in alphabetical order on the verso of the ballot paper in the left-hand column and finally continuing in the right-hand column;

- (b) on the recto of the ballot paper, there shall be a margin at the top of the left-hand column where the name of the constituency shall be printed;
- (c) on the verso of the ballot paper, there shall be a margin at the bottom for the official mark.
